

Police Support systems

Benefit system for crime victim

Victims are compensated by the national government under a benefit system.

- O For bereaved family members (Survivor Benefit)
- O For victims left disabled (Disability Benefit)
- O For victims who suffer a serious injury or illness

(Serious Injury or Illness Benefit)

[Reduction or adjustment of the benefit]

In case the offender may make a profit from the compensation benefit or the victim, also, is to blame for the case, All or part of the benefit may not be paid. Some adjustment will be conducted when the victim is to be paid by public compensation or compensation for damage.

The detective in charge of your case will notify you of following information.

- Investigation progress
- O The suspect's name and age when they are identified
- The prosecutor's office where the police sent the suspect
- The disposition of the case
- The location of the trial

etc.

- ◆ In accordance with the request of the victim, police officers working at a police box or at a residential police box will visit them in order not to be involved in another crime or to ease their worries.
- * Some victims don't want to recall the case or to be informed of the progress of the investigation. If you don't want to be informed, feel freely to tell us.

Victim support officers carry out following activities to ease the victim's worries caused by the crime.

- O Accompanying victims to hospital and coordinating with the doctor
- Accompanying victims to on-site investigations, police questioning and other investigations
- O Consulting victims about their worries
- O Introducing and arranging nongorvernment victim support organizations

Publicly financed support system

Police pay for following expenses to ease the burdens of victims.

- Counseling by a psychologist
- The morning-after pill
- A rent for the temporary shelter
- O Body transportation fee after the judicial autopsy

Support for Sexual Assault Survivors

Sexual assault impairs the dignity of victims and causes harsh damage to the victim's body and even the victim's mind.

To lighten the mental burden on victims, Police provide support for victims, for example, consulting, collecting evidence, returning evidence and accompanying victims to hospital by a police officer whose gender is designated by victims.

Support for Juvenile victims

Juveniles tend to suffer more serious psychological damage than adults and keep their painful feelings in themselves.

Police cooperate with juvenile support organizations such as Juvenile Support Center and consider juveniles' features and help juveniles to relieve their psychological pain and assist their rehabilitation.

Our request

Please note that police may ask victims and their family members to cooperate following things.

[Police questioning]

Investigators question you about the case.

Prosecutors and Judges may ask you similar questions too.

[Evidence submission]

Police may ask you to submit victim's clothes or belongings as evidence to back up our investigation.

[Attending on-site investigations]

you may be asked to attend on-site investigation.
